

OUTWARD REMITTANCE FOR INDIVIDUAL CUSTOMERS

1. Outward Remittance by Swift message via Vietcombank branches' channel

<i>Fee charged paid to the first intermediary foreign bank (if the remitter agrees to pay this fee)</i>	In USD: 10 USD/ transaction In JPY, EUR: 40 USD/ transaction Other foreign currencies: 20 USD/ transaction No deduct fee (apply for USD): 30 USD/ transaction
2. Investigation (Check the status/ Amendment/ Cancellation of payment order)	5 USD/ transaction (exclude Swift fee 5 USD/ transaction)

NOTE

1. Fees above do not include VAT. Customers should be charged additional VAT.
2. Transactions in foreign currencies are subject to the current regulations on foreign exchange management of the State Bank of Vietnam.
3. Other payable fees such as: Swift, Fax, postal rates, tax, fee charged by other associated banks...will be additionally charged on a basis of actual expenditure or according to the VCB fee schedule.
4. VCB shall not reimburse the Service charges and other fees collected by VCB in case that Client asks to cancel transactions or transactions fails to be implemented due to errors and/or mistakes out of VCB's faults.

Investigation (Check the status/ Amendment/ Cancellation of payment order)	200.000 VND/ transaction

NOTE

1. This fee applies to Swift money transfer service abroad on VCB Digibank.
2. The fees are exclusive of Value Added Tax (VAT).

3. Fee reduction policy (if any) only applies to VCB fees.
4. Fee charged by other associated banks...will be additionally charged on a basis of actual expenditure.
5. Each type of investigation (Check the status/ Amendment/ Cancellation of payment order) is only charged once on VCB Digibank.
6. Transactions in foreign currencies are subject to the current regulations on foreign exchange management of the State Bank of Vietnam.
7. VCB shall not reimburse the Service charges and other fees collected by VCB in case that Client asks to cancel transactions or transactions fails to be implemented due to errors and/or mistakes out of VCB's faults..
